

Site management

In addition to the completion of documentation, the site management takes on the tasks of obtaining permits, checking site safety and coordinating the construction activities on site.

This type of portfolio requires individual attention and is always based on your specifications and requirements.



Overview of typical tasks of our site management

invoice verification

Measurement and invoice verification are the basis for the claim for compensation of the executing company and are important components of the site management. Our qualified office staff ensure that your invoices and measurements are checked thoroughly. They have in-depth specialist knowledge and many years of professional experience.

- » Agreement on a uniform format with the biller
- » Review of the services rendered according to the scope of the construction services
- » Invoice and project scope verification in GAEB and DA11 format
- » Review of received invoices and delivery notes for factual, arithmetical and pricing correctness
- » In the case of lump-sum settlements, verification as to whether the construction work was carried out in accordance with the contract
- » Control of the verifiability of the invoices based on the number of items, order, quantity calculations, drawings and documents for all positions







Construction supervision is an elementary component for compliance with the regulations on construction sites in broadband expansion.

Our construction supervisors are responsible for efficiently supervising a project on site and ensuring proper execution of construction work on site.

Through careful construction supervision, defects or discrepancies can be identified and avoided at an early stage. This allows for quick intervention and ensures a high quality of the finished work.

Typical tasks of construction supervision:

- » Daily activities from service phase 8
- » Participation in the construction start-up meeting
- » Supervision and continuous monitoring of the individual construction sites
- » Initiation and implementation of control tests
- » On-site quality assurance: maintain and check the funding guidelines
- » Damage recording

- » Checking the implementation of the traffic law order
- » Construction site notification for the following week to relevant parties and agreements with authorities
- » Construction progress control
- » Construction progress documentation (LK2 documentation) for retrieving funding and SiGeKo documentation according to your specifications
- » Ecological construction support by our trained staff
